Our college is affiliated to the University of Kalyani, Kalyani, Nadia and aided by Govt. of West Bengal. The College has formed the RTI Cell from 2017. The college has a Governing Body and IQAC. It runs as per the rules and regulations made by University of Kalyani and Govt. of West Bengal from time to time. The College comes under "Grants-in-Aid" category of the Govt. of West Bengal and therefore, financial transactions are audited by the empanelled auditors recommended by the Director of Public Instructions, Education Directorate, Govt. of West Bengal.
